**Important Notes:**

- Under the Chemical Weapons (Convention) Ordinance (Cap. 578), operator of a facility requires a permit issued by the Director-General of Trade and Industry to operate the facility during a particular year if:
  - Schedule 1** chemicals (other than excluded Schedule 1 chemicals) are likely to be produced, acquired, retained or used at, or transferred from, the facility during the year. Schedule 1 chemicals are excluded chemicals in relation to a facility and to a year if –
    - the total amount of those chemicals likely to be acquired, retained or used at, or transferred from, the facility during the year does not exceed 100 grams;
    - those chemicals will not be produced at the facility during that year; and
    - those chemicals are intended only to be put to research, medical or pharmaceutical purposes;
  - an amount of a **Schedule 2** chemical exceeding, in the aggregate, the Schedule 2 permit threshold for that chemical is likely to be produced, processed or consumed at a plant comprising, or comprising part of, the facility during the year. The threshold is –
    - 1 kg for a chemical listed in Part A of Schedule 2 and designated with an "\*" ;
    - 100 kg for a chemical listed in Part A of Schedule 2 but is not designated with an "\*" ; or
    - 1 tonne for a chemical listed in Part B of Schedule 2; or
  - an amount of a **Schedule 3** chemical exceeding, in the aggregate, 30 tonnes of that chemical is likely to be produced at a plant comprising, or comprising part of, the facility during the year.
- The Chemical Weapons (Convention) Ordinance (Cap. 578) requires an operator to notify the Director-General of Trade and Industry of information relating to their facilities and the production of the concerned Unscheduled Discrete Organic Chemicals (UDOCs) in a year if the facility:
  - produced by synthesis during the previous calendar year more than 200 tonnes of UDOCs; or
  - comprise one or more plants which produced by synthesis during the previous year more than 30 tonnes of a UDOC containing the elements phosphorus, sulfur or fluorine (PSF-chemicals).
- A person who fails to comply with the permit and notification requirements commits an offence and shall be liable on conviction to a fine and imprisonment.
